N.B.:

As concerns the Risk Centre managed by the Bank of Italy and the CRIC managed by the SIA, the Bank may, in accordance with regulations in force, inform the person concerned of their overall and partial risk position as it results from information received by the Bank of Italy and also of risk data relating to jointly held accounts which the person may be party to. Where the person concerned wishes to know details of reports made on him/her even by each other intermediary participating in the two centralised risk information systems including data relating to jointly held accounts, the application must be addressed: for the risk centre managed by the Bank of Italy to the branch of the Bank of Italy located in the area in which the person concerned is legally resident; for the CRIC to SIA –Società Interbancaria per l'Automazione S.p.A., Via Taramelli 26 20124 Milan.

Similarly, with regard to the CIS managed by CRIF, the right to access and the exercise of other rights relates solely to data communicated to the CIS by our Bank or that it is in possession of as a result of interrogating the CIS itself, with the exclusion, therefore of data transmitted/recorded by other intermediaries participating in the system.

Where the person concerned wishes to know details of data recorded concerning him/her by each of the other intermediaries participating in the system also, the application must be addressed to CRIF S.p.A. – Ufficio Relazioni con il Pubblico, via Montebello 2/2 40121 Bologna.
